**Topic: “E-justice, Data Protection and Human Rights
in Japan, Germany, Italy and Central Asia”**

The aim of the workshop is to discuss current trends of digital transformation of judicial systems in Japan, Germany, Italy and three Central Asian countries such as Kyrgyzstan, Uzbekistan and Kazakhstan from a comparative perspective. Japan follows an incremental approach to implementation of digital transformation of judiciary. In 2022, several amendments concerning digitalization of civil litigation procedures were introduced in the Civil Procedural Code.

Germany and Italy have advanced experience in digital transformation of judiciary. For example, in Italy successful example of digitalization of civil proceedings is presented by the Trial Online platform. However, the process of its introduction revealed tremendous pitfalls. In Germany, lawyers and other professional justice users are forced to communicate electronically with the courts, and the courts must complete their internal digitization by 2025. Work is currently underway on online procedures and the use of artificial intelligence in the justice system.

In contrast, three Central Asian Countries such as Kyrgyzstan, Uzbekistan and Kazakhstan where digital transformation of justice sector through introducing e-justice initiatives is supported by foreign legal donors (the European Union guided mainly by German legal aid projects such as GIZ or IRZ, USAID and UNDP) reveals rapid implementation of ICT in justice system. However, for example, in Kyrgyzstan e-justice implementation shows mixed impact on administration of justice, ensuring the right to a fair trial, and balance between the principle of openness of courts and data privacy.

Overall, the workshop will provide an opportunity to analyze achievements and challenges those respective countries face in the field of digitalization of their judicial systems.
